How an Electric Bike Is Defined

- The state of Montana defines an electric bicycle as an "electric assisted bicycle." To be placed in this category, the motor must have a maximum speed of 20 mph. Both electric bicycles and traditional bicycles must adhere to the same rules of the road.



Licensing and Registration Requirements

- E-bikes are not required to meet the registration, licensing, or insurance requirements that standard motor vehicles are subject to.

Helmet Law

- Helmets are not required to operate an electric bicycle, and there is no minimum age requirement for e-bike riders.

Where Can I Ride My Electric Bike?

- E-bikes are allowed on both sidewalks and bike paths.

Missoula, MT

- **Allow Class I & II On Streets & Commuter Trails**
- **E-Bikes Are Not Formally Authorized For Use On City Open Space Trails**

BOULDER, CO

- Class I & II On Commuter Paths
- Prohibited On Open Space



COLORADO SPRINGS, CO

- Class I Allowed On Urban Trails
- Prohibited On Open Space
- Recently Completed An E-Bike Survey



BOISE, ID

- **Class I, II, & III Allowed On Streets, Sidewalks, Bike Lanes & Green Belt Paths**
- **No E-Bikes On Open Space Trails**
- **City Provides A Map Of ADA Open Space Trails Where E-Bikes Are Allowed**



DURANGO, CO

- **Class I & II Allowed On City Hard Surfaced Trails**
- **Prohibited On Open Space Trails With The Exception Of Twin Buttes Where There Is An Ongoing 1 Year Trail Period For Class I E-Bikes**





PARK CITY, UT

- **Class I & II Allowed On Paved Trails**
- **Class I Allowed On Soft Surface Trails Wider Than 5 Feet**
- **Class I Allowed On Single Track For Riders 65 + With Permit**

BOULDER COUNTY, CO

- Class I & II Allowed On Identified Regional & Plains Trails
- E-Bikes Prohibited On All Other Open Space Trails





JEFFERSON COUNTY, CO

- Class I Allowed On Natural Surfaced Trails
- Class I & II Allowed On Paved Trails



LARIMER COUNTY, CO

- **Class I & II Allowed On Paved Trails**
- **E-Bikes Are Prohibited All Naturally Surfaced Trails With The Exception Of The Devils Backbone Trail Where 30 Lotto Selected Riders Can Ride Class I E-Bikes Until February 15, 2021**
