The estimated cost for maintenance, electrical energy, and administration for the amended district will be \$50,704.00. The additional sixteen (16) lights together with the removal of 11.02 acres from the District will result in the estimated cost being \$.0256 per square foot of property owned, said amount to be paid by all property owners in the District. The currently assessed amount is \$.0187 per square foot.

Property owners have 15 days from the first date of publication of this notice to file a written protest with the clerk of the commission at the address below.
