March 25-27

- All 3 shifts FD went through the training
- There was two different scenarios so that each station arrived first and second.
- First scenario started at Station 1 with a staged arrival time

Realistic Training

- Unknown structure to our firefighters
- Had to make decisions based upon their outside findings
- They had to work around furniture and other household items inside and out
- They could do whatever they would like to do inside the structure, including forcing doors, spraying water, and opening the ceiling.





Goals of the training

- Size up the structure with a radio report
- Perform a 360 to identify any hazards
 - Identify two electrical meters and identify that this was a duplex
- Secure a hydrant that was 100' away
- Pull handline(s) and put out the fire
- Search the structure
- Find any hidden fires
- Determine any other priorities
 - Ladder to the second floor
 - Exhaust Fan
 - Medical supplies for the victim
 - Rapid Intervention Team
 - 2nd handline



1st Scenario

- 2nd floor fire
- Smoke coming from the second-floor window
- They had determined which door to enter
- Encountered: Steep set of stairs, force the front door, move around furniture including clothing and sofa.
- They found at least one unconscious victim

2nd Scenario

- Basement fire with smoke coming from the basement window
- Changed the layout of the first floor with OSB
- Had to determine the correct entry point
- Basement was long dark and had multiple rooms that they had to search
- Had to find the fire and extinguish the fire
- Command had to identify how this house was built– balloon frame
- The second arriving crew would find a victim with a search above the fire



In conclusion

- Great partnership with the college
 - Easy access to the building
 - Quick to get into the building for the training
- HPD and Sheriff's Dept. joint SWAT team also utilized the structure for training evolutions.
- These types of structures better prepare the department with realistic conditions.

Present Situation: The City of Helena and Lewis and Clark County jointly analyze and

agree each year on a recommended tipping fee for the operation of the City Transfer Station and the Lewis and Clark County Landfill. The sum of these two individual tipping fees make-up the overall tipping fee charged at the Transfer Station. The City of Helena is proposing the Transfer Station tipping fee at \$36.75 per ton. The County is proposing a tipping fee to \$22.00 per ton. Therefore, the Public Works Department is recommending a total tipping fee of \$58.75 per ton (an increase of

\$4.00).

A RESOLUTION OF INTENTION TO SET FEES CHARGED FOR DISPOSAL OF GARBAGE AND REFUSE AT THE CITY OF HELENA TRANSFER STATION AND REPEAL RESOLUTION NO. 20832

WHEREAS, the City of Helena operates the "Transfer Station" to provide sanitary disposal of garbage and refuse, collection of recyclable materials, and diversion of usable material;

WHEREAS, the City pays a tipping fee charged by the County for use of the landfill that needs to be recovered in order to keep up with paying for the costs of doing business;

WHEREAS, the City is authorized to establish such fees as may be necessary to operate its facilities to ensure positive cash flow; and

WHEREAS, it appears to be in the best interests of the City of Helena and the inhabitants thereof that Resolution No. 20832 be repealed and a new resolution setting fees be enacted.

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:

Section 1. That it is the intention of the Helena City Commission to adopt the following transfer station tipping fees:

A. These tipping fees apply to all Transfer Station customers:

Minimum transaction/tipping fee (Permit):\$0.60/20 lbs.

Resol.	

Minimum transaction/tipping fee (Non-Permit):\$6.00/200 lbs.

Permit holders that exceed the yearly allowance will be cash customers.

The total Tipping Fee is calculated below:

Transfer Station Tipping Fee \$36.75

Landfill Tipping Fee \$22.00

Total Tipping Fee \$58.75/Ton

The total tipping fee is applied to all garbage, refuse, recyclable materials, and diverted materials at the transfer station. The cost of clean loads of recycled materials are charged to either the City of Helena Residential Fund, other participating districts, or other governmental entities that have a transfer station agreement with the City of Helena, but is not counted as tonnage against permits.

B. Any additional charges or tipping fees can be paid by using any residential permit credit granted by the City of Helena, Scratchgravel, or other participating districts, as shown below:

Subject: Request for an Exclusive Right-of-Way Permit for the Installation of Groundwater Monitoring Wells (Yellowstone Drive Well Set)

Resource Environmental, LLC (RELLC) is requesting an Exclusive Right-of-Way Use Permit for the installation of groundwater monitoring wells. Approximate monitoring well locations are shown on Attachment B (Figure 3-2 from the latest Helena Terminals Groundwater Monitoring Report [Trihydro 2025-03]). Specific locations are shown in the attached Site Plan included as Attachment C. RELLC has been working with the Montana Department of Environmental Quality (DEQ) to characterize and remediate groundwater contamination presumably associated with historic releases from the Phillips 66 Products Terminal (318 East US HWY 12) and the adjacent Yellowstone Pipe Line Pump Station. Attachment B (Figure 3-2) shows approximate extents of a groundwater contamination plume as defined by benzene concentrations in groundwater. Groundwater flow is generally to the north/northeast in this area. As shown on the figure, the plume is not fully defined to the west. The plume extent needs to be further refined to guide potential future remediation; the proposed new wells should help to refine plume extents.

The "well set" shown on Attachments B and C represent multiple borings spaced within 6 feet of each other. Up to three screened intervals will be selected in the field, by the field geologist, based on field observations and field screening data. Each screened interval will be completed as a separate well in a separate boring. At the well set location, if contamination is identified in the field, three screened intervals/three wells will be required: a shallow screened interval straddling the water table, a deeper screened interval targeting the area of identified contamination, and a still-deeper interval set below contamination installed to provide vertical delineation of the contamination. If contamination is not identified, the vertical delineation well would not be required; only two wells would be installed.

As requested by City of Helena Public Works/Engineering, the proposed wells would be completed in the "Landscaped BLVD." portion of the right of way. A "Local Road/Private Road" schematic provided by the City of Helena illustrating the Landscaped BLVD is included as Attachment D. Assuming 3 borings are needed, a 20-ft by 7-ft rectangle has been plotted within the Landscaped BLVD on the Attachment C Site Plan. Each of the three borings would be completed within this rectangle. A survey map provided by the City of Helena is overlain on the Attachment C Site Plan. The rectangle description is provided below, using the survey map "Iron Pins" as reference points.

Yellowstone Drive Well Set Rectangle: The northwestern edge of the "Sidewalk" (which does not yet exist) will be established by locating the survey pins southwest and northeast of the proposed well set location. As shown on the Attachment C Site Plan, the

rectangle representing the well set location will be placed within the Landscaped BLVD, 28 ft northeast of the southwest survey pin.

The required Certificate of Liability Insurance is provided as Attachment E. Pending approval of this application, and prior to well installation, a professional surveyor will locate and mark the area of the rectangles, as described above. The approximate locations of known utilities are shown on the Attachment C Site Plan; the proposed boring locations do not interfere with known utilities. Should currently unidentified utilities or other obstructions prevent well installation within the above-referenced well set rectangles, RELLC will consult with the City of Helena Public Works regarding potential alternate drilling locations. Drilling will not be conducted beyond the surveyed rectangle without City of Helena consent.

Fieldwork is tentatively scheduled to begin in mid-May 2025. Prior to drilling, a public utility locate will be completed, and drilling locations will be potholed with a vacuum truck to a depth of 8 ft below ground surface to confirm utility absence. It is anticipated that well installation will be completed by the end of June 2025.




ATTACHMENT B

APPROXIMATE WELL LOCATION MAP





SITE PLAN






LOCAL ROAD/PRIVATE ROAD SCHEMATIC

LETTER OF REQUEST

Subject: Request for an Exclusive Right-of-Way Permit for the Installation of Groundwater Monitoring Wells (B Street)

Resource Environmental, LLC (RELLC) is requesting an Exclusive Right-of-Way Use Permit for the installation of groundwater monitoring wells. Approximate monitoring well locations are shown on Attachment B (Figure 3-2 from the latest Helena Terminals Groundwater Monitoring Report [Trihydro 2025-03]). Specific locations are shown in the attached Site Plan included as Attachment C. RELLC has been working with the Montana Department of Environmental Quality (DEQ) to characterize and remediate groundwater contamination presumably associated with historic releases from the Phillips 66 Products Terminal (318 East US HWY 12) and the adjacent Yellowstone Pipe Line Pump Station. Attachment B (Figure 3-2) shows approximate extents of a groundwater contamination plume as defined by benzene concentrations in groundwater. Groundwater flow is generally to the north/northeast in this area. As shown on the figure, the down-gradientmost (northern) unimpacted monitoring wells (CMW-71D, CMW-72D, and CMW-73D) are more than 1,000 feet (ft) from existing contaminated monitoring wells CMW-69D and CMW-70D. The plume extent needs to be further refined to guide potential future remediation; the proposed new wells should help to refine plume extents.

The "well set" shown on Attachments B and C represents multiple borings spaced within 6 feet of each other. Up to three screened intervals will be selected in the field, by the field geologist, based on field observations and field screening data. Each screened interval will be completed as a separate well in a separate boring. At the well set location, if contamination is identified in the field, three screened intervals/three wells will be required: a shallow screened interval straddling the water table, a deeper screened interval targeting the area of identified contamination, and a still-deeper interval set below contamination installed to provide vertical delineation of the contamination. If contamination is not identified, the vertical delineation well would not be required; only two wells would be installed.

As requested by City of Helena Public Works/Engineering, the proposed wells would be completed in the "Landscaped BLVD." portion of the right of way. A "Local Road/Private Road" schematic provided by the City of Helena illustrating the Landscaped BLVD is included as Attachment D. Assuming 3 borings are needed, a 20-ft by 7-ft rectangle has been plotted within the Landscaped BLVD on the Attachment C Site Plan. Each of the three borings would be completed within this rectangle. A survey map provided by the City of Helena is overlain on the Attachment C Site Plan. The rectangle description is provided below, using the survey map "Iron Pins" and "Block Corner Monuments" as reference points.

B Street Well Set Rectangle: The western edge of the "Sidewalk" (which does not yet exist) will be established by locating the block corner monument south of the proposed well set location and the survey pin north of the well set location, as shown on the Attachment C Site Plan. The rectangle representing the well set location will be placed within the Landscaped BLVD, 6 ft north of the block corner monument.

The required Certificate of Liability Insurance is provided as Attachment E. Pending approval of this application, and prior to well installation, a professional surveyor will locate and mark the area of the rectangle, as described above. The approximate locations of known utilities are shown on the Attachment C Site Plan; the proposed boring locations do not interfere with known utilities. Should currently unidentified utilities or other obstructions prevent well installation within the above-referenced well set rectangle, RELLC will consult with the City of Helena Public Works regarding potential alternate drilling locations. Drilling will not be conducted beyond the surveyed rectangle without City of Helena consent.

Fieldwork is tentatively scheduled to begin in mid-May 2025. Prior to drilling, a public utility locate will be completed, and drilling locations will be potholed with a vacuum truck to a depth of 8 ft below ground surface to confirm utility absence. It is anticipated that well installation will be completed by the end of June 2025.





APPROXIMATE WELL LOCATION MAP





SITE PLAN






LOCAL ROAD/PRIVATE ROAD SCHEMATIC
